Approval to Provide Financial Incentive to Dallas College Students and Employees who Provide Voluntary Proof of Covid-19 Vaccination

The Chancellor recommends approval of a financial incentive payment for students and employees.

Purpose

To aid in mitigating the spread of COVID-19

Background

Dallas College would like to utilize Higher Education Emergency Relief Fund III funds of the American Rescue Plan Act of 2021 to provide financial incentives to employees and students who voluntarily present proof of the COVID-19 vaccination. The purpose of the plan is to incentivize more students and employees to get vaccinated for COVID-19. The proposal is to pay employees \$500 once fully vaccinated and will have the payment added to their paycheck after documentation is provided. Registered students will be paid \$100 per vaccination up to \$200 for full vaccination proof and can chose either cash or direct deposit to their account. Payments will be made irrespective of vaccination date.

Dallas College will offer COVID-19 vaccines at each Dallas College campus twice per week. It is anticipated that the employee payment will not exceed \$3.5 million and the student payment will not exceed \$6 million. This incentive program will end November 15, 2021
